- Dispense prescriptions of various types of medicines as directed by the pharmacist,
- Provide medicines and parapharmaceutical products to the clients,
- Manage the pharmacy's administrative tasks and routine.

This qualification holder may be employed in private and public pharmacies, pharmaceutical companies, cosmetics industries and crafts, public services, national organisations for medicines, and research centers.
