#### 3. Profile of skills and competences

LEARNING OUTCOMES (KNOWLEDGE, SKILLS, COMPETENCES). A typical holder of the certificate is able to:

#### **KNOWLEDGE**

- Demonstrate basic knowledge about the function of the human body.
- State basic knowledge of anatomy, physiology, dermatology, and rehabilitation.
- Record the problems related to nails and soles.
- State the practices for the proper cutting of nails.
- Describe the most frequent conditions of nails (ingrown nail, fungi, paronychia, inflammations, etc.).
- State the conditions when medical consultation is required for the problem.
- Present the basic principles of chromatology.
- Explain the method for the control and operation of the paraffin device, file machine and the sterilisation autoclave.
- Discern the necessary professional tools and the use thereof.

#### **SKILLS**

- Undertake the beautification of nails using various techniques and tools.
- Add nail prostheses using safe techniques and suitable tools.
- Manage effortlessly the materials for prosthetic nails, such as gel and lamp, with silk or acrylic.
- Beautify by applying drawings and nail paint on the surface of nails.
- Apply practical exercises for massaging and soothing feet.
- Organise the procedure for taking fingerprints (negatives positives).
- Design a protective orthoplastic application for the fingertip area treated.
- Determine and evaluate the diagnostic data after examining nails in hands and feet.
- Classify and select the proper use of materials and tools for podology.
- Observe the rules of hygiene both for treating and performing minor operations during manicure and pedicure.
- Demonstrate basic computer skills.

#### **COMPETENCES**

- Act with responsibility based on the ethics of his/her profession.
- Work independently in his/her professional field of expertise
- Collaborate effectively with other professionals within the context of team work.

#### 4. Range of occupations accessible to the holder of the certificate <sup>3</sup>

The holder of the Diploma of this specialization can work in rehabilitation centers, orthopedic clinics etc. as long as the responsibility and supervision of the activities they take up relies on the relevant doctor. They can also work at enterprises dealing with nail care and grooming.

The Vocational Training Diploma is recognized as a qualification for appointment in the public sector falling in the category S.E. (Secondary Education) according to the Presidential Decree no.50/2001 (Greek Official Gazette 39/Vol.A/5-3-2001).

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
