3. Profile of skills and competences

LEARNING OUTCOMES (KNOWLEDGE, SKILLS, COMPETENCES). A typical holder of the certificate is able to:

KNOWLEDGE

- State in detail the organs that make up the respiratory, urinary, reproductive and nervous system, and the muscles and bones that form the skeletal and muscular system and describes in general terms the operation thereof.
- Present the exercises and the means used to exercise and massage for patients with mobility problems.
- Demonstrate the basic principles for patient safety during exercise.
- Discern and describe accurately the techniques used for the rehabilitation of patients suffering from orthopaedic, neurological, rheumatology, and cardiorespiratory conditions.
- Present adequately knowledge about the spa treatment and hydrotherapy, applied in a personal tank and pool.
- Analyze the hydrotherapy programmes suitable for orthopaedic, neurological, rheumatologic and cardiorespiratory, gynaecological and dermatological diseases, sports injuries, people with disabilities and the elderly.
- Demonstrate the basic principles governing the physical medicine and rehabilitation therapies.
- Formulate basic knowledge of first aid and hygiene in baths, spas or physiotherapy sites using water as the basis for treatment.

SKILLS

- Follow, without errors and deviations, the instructions issued by specialists with regard to the exercise of patients and the application of hydrotherapy programmes, thus assisting to the healing work of the physiotherapist.
- Apply, under the physiotherapist instructions, the basic methods for kinesiotherapy and massage.
- Observe the hygiene rules provided in his/her employment site (spas, baths, hydrotherapy centres, etc.).

COMPETENCES

- Work in accordance with the ethics of his/her profession, respecting the rights, the needs, the dignity, and the values
 of patients.
- Undertake initiatives within his/her knowledge, capabilities and experience, while always informing specialists and with the consent both of them and of patients.
- Collaborate effectively with other workers in spas, baths or any other site of employment, without creating problems or risking patient safety.

The holder of this specialisation certificate may work in spas, hotel-spas, and in other businesses providing similar services.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector falling in the category S.E. (Secondary Education) according to the Presidential Decree no.50/2001 (Greek Official Gazette 39/Vol.A/5-3-2001).

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
