3. Profile of skills and competences

LEARNING OUTCOMES (KNOWLEDGE, SKILLS, COMPETENCES). A typical holder of the certificate is able to:

KNOWLEDGE

- Specify the features and the skills of a captain in a summer camp and the duties and responsibilities of a team leader.
- Analyse the special problems that may come up from the behaviour of a child during summer camp, depending on their age and the indicative methods for dealing with them.
- Describe in detail the summer camp and the various activities, the necessity thereof and the methods for applying and conducting them for children aged between 6 and 13 years old.
- List the facilities of a summer camp, its operations and the legislative framework governing them, without having to consult a manual.
- Specify the purposes of the summer camp and the benefits for the training, development, and socialization of children.
- · Formulate the basic principles of marketing, advertising, management, administration and personnel training.
- Specify in a clear manner the rules of hygiene and the methods for promptly dealing with emergencies (appropriate first aid).

SKILLS

- Occupy the children in a creative manner, through various activities seeking to the cognitive development of the children, their proper socialization and physical development.
- Attend to basic needs of children during their stay in the summer camp (boarding, hygiene, clothing, resting / going to bed).
- Fill in the relevant summer camp forms regarding the camper on a daily basis.
- Help the employees' responsible in the financial and administrative requirements of the camp.
- Provide first aid, until the specialized physician undertakes, to the child / person at risk.
- Inform the parents, in collaboration and with understanding with the manager, about any problems faced by children during their stay in the summer camp.

COMPETENCES

- Properly perform the instructions issued to him/her by superiors with regard to the training, education, recreation, boarding or resting of children and the practical needs of the camp.
- Effectively collaborate with the employees in the camp, in accordance with its regulations and culture.

The holder of this specialisation certificate may work in camps for children.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector falling in the category S.E. (Secondary Education) according to the Presidential Decree no.50/2001 (Greek Official Gazette 39/Vol.A/5-3-2001).

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
