- Describe the basic principles of ecology and the operation of ecosystems inside and outside of Greece.
- List the forms of pollution and soft energy technologies.
- · Present the basic elements of geology edaphology and the interactions thereof with the environment.
- Specify the principles of integrated organic ecological treatment of pests and diseases.
- Underline the importance of agrotourism for the better evaluation of the environment.
- Discern the importance and the methods of irrigating organic cultivations.
- Formulate the methods for standardization, packaging, and processing organic products.
- Explain the methods for the preparation of biological and chemical fertilisers.

- Perform the cultivating works and care for organic cultivations.
- Apply an integrated organic ecological treatment of pests and diseases of organic cultivations.
- · Prepare biological fertilisers.
- Organise an irrigation system in organic cultivations.
- Operate machinery and tools used in organic cultivations.
- Apply the principles of costing in biological cultivations.
- Conduct a quality control to organic products.
- Perform edaphology analyses.
- Identify the main fungal and viral diseases of organic cultivations.

- Suggest to workers the proper method for applying organic pesticides.
- Follow the instructions and regulations of the competent bodies and scientists.
- Adopt the basic principles and the philosophy of organic agriculture.

The holder of this diploma can work as an organics producer, as a consultant on environmental protection issues, as a specialist on organic products certification, as a freelancer for co-operative organisations, local authorities, public organisations and services.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector falling in the category S.E. (Secondary Education) according to the Presidential Decree no.50/2001 (Greek Official Gazette 39/Vol.A/5-3-2001).
