3. Profile of skills and competences

LEARNING OUTCOMES (KNOWLEDGE, SKILLS, COMPETENCES). A typical holder of the certificate is able to:

KNOWLEDGE

- Describe the types of paintings based on their techniques and materials, regardless of their period of creation.
- State the materials and their properties, the tools and the appliances necessary for the preservation of paintings.
- Describe the general principles for the preservation of a) textiles, b) wood woodcut, c) portable image d) murals (fresco, secco) and e) oil paintings.
- · Recognize the basic rules of aesthetics and harmony.
- Discern the development of fine arts (painting, sculpture, architecture) over the years, and the artistic creations of various cultures and artistic movements.
- List the components of the photographic camera and describes its basic functions.
- Recognize the rules of linear and freehand drawing and hierarchically classifies the drawing stages.
- List the chemical nomenclature and its basic theory related to the procedures for the preservation and restoration of paintings and classify it as organic and inorganic.
- List the environmental parameters that affect works of art in an internal microclimate (museums, exhibitions, warehouses etc.).
- Describe the process to capture paintings using design tools and names the internationally accepted symbols used (Venice Charter).

SKILLS

- Evaluate wear and preserve paintings of all type, using suitable methods for the case in question.
- Apply preventive maintenance to paintings, whether this refers to entire works or specific areas thereof.
- Easily operate the technological equipment and the instruments of the workshop.
- Proceed to metric analyses, harmonic engraving and mapping of the works preserved.
- Attend to and supervise the preservation works for all paintings, by filling in the special sheet provided in accordance with the rules of ethics.
- Effectively operate the photographic camera in order to shoot the entire works under preservation, or parts thereof.
- Take steps for the protection of the painting exhibition or safe keeping areas with regard to external environmental conditions (temperature, humidity, etc.).
- Take the necessary protection and health measures in the workshop or in any other area where the preservation takes place.

COMPETENCES

- Undertake the preservation of paintings autonomously and be responsible for the quality and result of his/her work.
- Follow directions under the artistic curator or workshop head, understand the method of application thereof and keep the time schedules set
- Collaborate with other specialties, such as painters, designers, suppliers, etc. and with chemical, physicals laboratories, etc. in order to deal with composite and specialized problems related to the preservation of paintings.

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.

The holder of this diploma can work as a conservation employee in museums and painting exhibitions, and as a self- employed professional in private and public institutions that are holders of paintings.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector falling in the category S.E. (Secondary Education) according to the Presidential Decree no.50/2001 (Greek Official Gazette 39/Vol.A/5-3-2001).
