## 3. Profile of skills and competences

LEARNING OUTCOMES (KNOWLEDGE, SKILLS, COMPETENCES). A typical holder of the certificate is able to:

### KNOWLEDGE

- Reproduce knowledge about prehospital and emergency medicine organisation and the role of the paramedic during
  professional practice.
- Recognise the ambulance's basic equipment, as well as the operation of any available machinery and devices.
- Summarise basic principles of the human body physiology and the basic principles of implementing first aid.
- Identify cases of emergency and the approach thereof in terms of systems (respiratory, circulatory, cardiac, and neural), prioritising the patient's needs.
- Hold basic knowledge for safe driving.

### SKILLS

- Administer pharmaceuticals via all routes of administration based on the doctor's prescription.
- Assess acute illnesses and functional disorders in all systems of the human body requiring emergency care, transporting patients safely by any means of transport to the respective health unit.
- Interpret standard pathological images per system and transmit information themselves through telecommunications means (VHF, telemedicine).
- Offer mechanical assistance for breathing and electrical resuscitation of cardiac arrest (use of defibrillator), by applying medical protocols and accurately performing the instructions issued by the Emergency Medicine physician.
- Apply hygiene rules for themselves and the patients.

### COMPETENCES

- Follow instructions by the Emergency Aid Centre.
- If no time for waiting is not an option, undertake the necessary initiatives.
- Collaborate with rescue teams in mass accidents and difficult situations.
- Work with responsibility, following the profession's rules of ethics.

### 4. Range of occupations accessible to the holder of the certificate <sup>3</sup>

The holder of this diploma can work in Intensive Care Units, where they shall assist the ICU nurses and doctors during the exercise of their works and participate in nursing operations which correspond to the level and subject of their education, specialisation and experience. The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/5-3-2001), as currently in force.
