The VET graduate of this specialty can be employed in the private sector, in many sectors of wholesale and retail trade, in the sales departments of various companies providing goods and services, in dealerships of imported products, etc. The holder can also work in public sector companies (e.g., in public telecommunications organisations providing mobile telephony or internet connection).

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/5-3-2001), as in effect.

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
