- Understand and execute any developments in Macroeconomic figures that inevitably affect the operation of the undertaking, and in Microeconomic figures, in order to comprehend, advise on and implement the bank's policy.
- Analyse the details of bank orders, depending on their country of execution.
- Discern the types of cheques and their necessary content in order to be valid.
- Identify the concept and distinctions among bank accounts (e.g. natural persons or legal entities).
- Describe the types of interest rates with regard to banking products.

- Promote Financial Products to customers.
- Operate banking IT systems.
- Inform bank customers on the advantages of different types of accounts.
- Manage Cash Available to be utilised by customers.
- Conduct periodic, regular or extraordinary inspections to ensure both the prevention and the resolution and restoration of any malfunctions and problems.
- Analyse, expand and evaluate the financial statements of associates and other companies, whether they are published
 or not, for the purpose of market research and in order to provide appropriate advice for the implementation of a financial
 agreement.
- Inform interested parties on the role of interest rates per type and per bank product.

- Treat the bank's customers with a spirit of cooperation.
- Act in accordance with the professional rules of conduct.
- Collaborate effectively with all bank departments in the context of group projects, in order to achieve the purposes and
 objectives of the institution.
- Act in accordance with the principles, procedures, policies and culture of the bank.

4. Range of occupations accessible to the holder of the certificate ³

The VET graduate of this specialty can be employed in Banks and other Financial Institutions (Cooperative Banks, Leasing Companies, Receivables Agencies, Business Risks, Mutual Funds Management, Portfolio Management, etc.), as well as in the financial department of other companies and public bodies. The holder may also work as a freelancer in Financial and Insurance Consultants' offices or establish similar undertakings.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/5-3-2001), as in effect.

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
