- Negotiate and conclude agreements regarding all types of trading transactions for individual investors or companies on the Stock Exchange.
- · Conduct sales, monitor and analyse the stock market.
- Create a Portfolio.
- Conduct searches for all necessary trade information.
- Negotiate the delivery of securities to customers and to the Greek Central Securities Depository SA.

COMPETENCES

- Develop communication skills in order to deal in a positive manner and facilitate the collaboration with customers, entrepreneurs, Stock Exchange and Money Market institutions, and specialised professionals.
- Ensure permanent and direct contact with the relevant stock markets, trading partners and companies.
- Act in accordance with the professional rules of conduct.

4. Range of occupations accessible to the holder of the certificate ³

The VET graduate of this specialty can be employed either in stock exchange offices or in institutional investors (e.g., companies, mutual funds, investment companies) and banks. In particular, in limited companies receiving and transmitting orders, in stock exchange companies, investment companies, in companies listed on the Athens Stock Exchange (ATHEX), in mutual fund management companies, in portfolio investment companies, in public or private banks and insurance companies.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/5-3-2001), as in effect.

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
