- Autonomously manage a driving school and handle the affairs of their clients with the Greek Ministry of Infrastructure and Transport.
- Provide theoretical and practical training to prospective drivers of each category.
- Adapt the teaching technique according to the level of knowledge of each prospective driver or their specific situation and need.
- Effectively inspect the vehicle and take appropriate action for its safe operation.

The holder of this diploma can run their own driving school for automobile and motorcycle drivers or be employed as an instructor in a drivers school and/or traffic education parks.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/532001), as currently in force.

The Certificate supplement provides additional information about the certificate and does not have any legal status in itself. Its format is based on the Decision (EU) 2018/646 of the European Parliament and of the Council of 18 April 2018 on a common framework for the provision of better services for skills and qualifications (Europass) and repealing Decision No 2241/2004/EC.
