Learning outcomes: Knowledge, skills and competences.

A typical holder of the certificate is able to:

KNOWLEDGE:

- Adequately present the basic knowledge pertaining to human body and skin anatomy, physiology and dermatology.
- Determine the various types of skin and skin conditions.
- Recognize the various cosmetic products, their role, and their mode of use, the indications and contraindications.
- Report on the various body and face therapies, face and body massaging and the various depilation methods.
- Make the distinction of concepts and definitions between professional and amateur make up, chromatology, hand and foot care.

SKILLS

- Recognize the different skin types (oily, dry etc), skin conditions (acneic, dehydrated skin etc) and select the appropriate cosmetic products and therapeutic regimens for every type of skin and skin condition
- Effectively use suitable machines, instruments and materials on ad hoc basis (person's health condition, pharmaceutical treatment, allergies, skin type, age, needs etc).
- Offer safely services without risking the personal or customer health and safety.
- Effectively promote cosmetic products and services focusing always on what is best for the customer.

COMPETENCES

- Effectively cooperate with scientists of other specialties (dermatologists, endocrinologists, gynecologists, plastic surgeons, fitness trainers, physiotherapists) deemed necessary in treating any problems encountered.
- Assess each case and select the correct therapeutic regimen and approach, using the appropriate machinery, instruments and materials depending on the person's health condition, pharmaceutical treatment, allergies, skin type, age etc.
- Safely plan the offered services without risking the personal or customer health and safety.

4. Range of occupations accessible to the holder of the certificate³

The VET graduate of this specialty may offer health/beauty and wellness services in multifunctional aesthetics and weight-loss centers, make-up and aesthetics institutes, massage centers, cosmetics production industries, cosmetics companies, water therapy centers-SPA operating independently or within an organized hotel unit. Moreover, the diploma holder may work in dermatology and plastic surgery office as assistant. Another possibility is to work in theater, television and cinema.

The Diploma is recognized as a formal qualification for recruitment in the public sector in the Secondary Education graduate category by virtue of the PD 50/2001 (Government Gazette. 39/A/5-3-2001), as in effect.
