Thalassotherapy Centers operating in organized hotel facilities, urban centers with different names (city spa, daily spa etc), Health centers (Orthopedic clinics and medical rehabilitation centers and the guidance of responsible physicians), enterprises involved in the orthopedic shoe), as a freelance owning a private studio.
