3. Profile of skills and competences

LEARNING OUTCOMES (KNOWLEDGE, SKILLS, COMPETENCES). A typical holder of the certificate is able to:

KNOWLEDGE

- Recognise and describe the tools, software and types of files necessary for digital processing of animation and graphic design.
- Describe the instruments and materials for designing images and graphics by hand.
- Recognise the basics of drawing, colour and the basic principles of composition.
- Distinguish the basic elements of music and the basic principles for script development and direction organisation.
- Indicate the properties of colours and their value for the composition of drawings and graphics.
- Interpret and decipher the colour of graphic arts and multimedia applications in relation to colour systems, models and conditions.
- List digital tools helping to create motion in two (2D) and three-dimensional (3D) projects.

SKILLS

- Draw sketches for cartoon films and multimedia screens.
- Design multiple models by hand, following the rules of motion for the presentation of visual solutions for themes intended for animation.
- Digitally process images and drawings using image and model editing software.
- Organise the equipment for the production of animation regardless of the technique followed.
- Process preliminary designs in software for the design of characters in motion for 2D and 3D animation.
- Digitally compose images, graphics, texts, sounds, music, and video in a single file, for the complete presentation of works through the harmonic composition of various elements.

COMPETENCES

- Follow instructions by the artistic curator during the performance of their duties, understand how to implement said instructions, and ensure compliance with the timetables set.
- Work independently by undertaking part of an animation project and be responsible for its completion and quality.
- Collaborate with persons of other specialties, such as script writers, directors, musicians, illustrators, graphic designers, video editor, etc. in order to complete composite projects.

4. Range of occupations accessible to the holder of the certificate ³

The holder of this specialisation certificate may work as animation technician in advertising production companies, TV and cinema films, TV stations, multimedia companies, institutions, public bodies and agencies where they can construct models for the representation of various data. The holder may also work as a freelancer in their own studio. The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/5-3-2001), as currently in force.
