- Be cognizant of the basic principles of customer service and have practical chemistry knowledge relevant to hairdressing
- Know the use of materials for hair cutting, hair colour, decolouring, hair washing and any other hair salon service

SKILLS:

- Apply the techniques in hair cutting, hair grooming, colouring and decolouring, hair curling and hair straightening, face shaving, grooming techniques for beard, hair and capillary
- Distinguish and create combinations of colours and colour hues
- Place, take care of and preserve extensions, postiche, wigs
- Apply techniques and disinfection materials of hair dressing tools and workplace
- Maintain and replace the hair salon equipment aimed at good operation, aesthetic value and accident prevention
- Diagnose hair's condition and check internal work area conditions
- Seek substantiated ways for customer satisfaction

COMPETENCES

- Implement original hairdressing creations
- Effectively implement customer preferences in hairstyle or haircut
- Easily adapt to new hairdressing fashion techniques and trends
- Respect Health and Safety rules at the workplace

4. Range of occupations accessible to the holder of the certificate ³

The VET graduate of this specialty may work as hairdresser in a hair salon, in companies of theatrical and cinema producers, in hotels, clinics, hospitals, cruise ships, fitness clubs, in public sector bodies, as Technical Consultant in hair salon cosmetic products companies and may also work as instructor in Education and Training bodies. The diploma is a prerequisite for exercising the Hairdresser-Barber profession (Law 4281/2014, as in effect).

The Diploma is recognized as a formal qualification for recruitment in the public sector in the Secondary Education graduate category by virtue of the PD 50/2001 (Government Gazette 39/A'/5-3-2001), as in effect.
