- Conduct market research and promote tourism products in selected markets.

The VET graduate of this specialty can work in Travel Agencies and Tourism Undertakings which are active in the field of Religious Tourism, in Public bodies, institutions and municipalities in the field of Religious Tourism, in Organisations and Bodies of the Church of Greece in relation to Religious Tourism, in private companies with services or synergies related to Religious Tourism and Pilgrimage Tours.

The Vocational Training Diploma is recognised as a qualification for appointment in the public sector according to the Presidential Decree no. 50/2001 (Greek Official Gazette 39/Vol. A/5-3-2001), as in effect.
